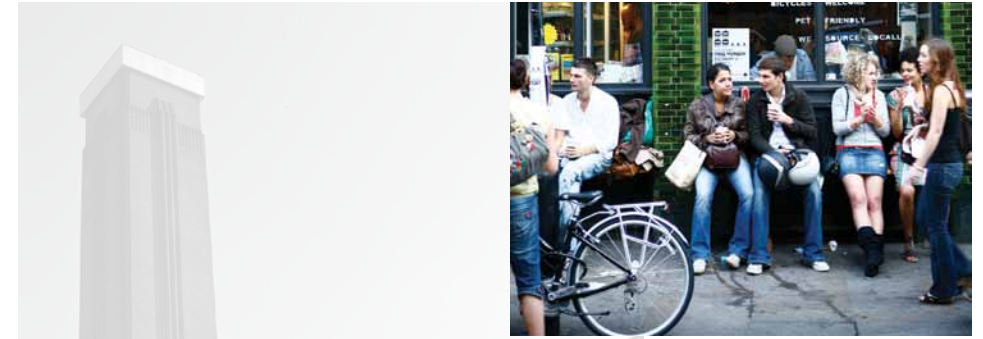

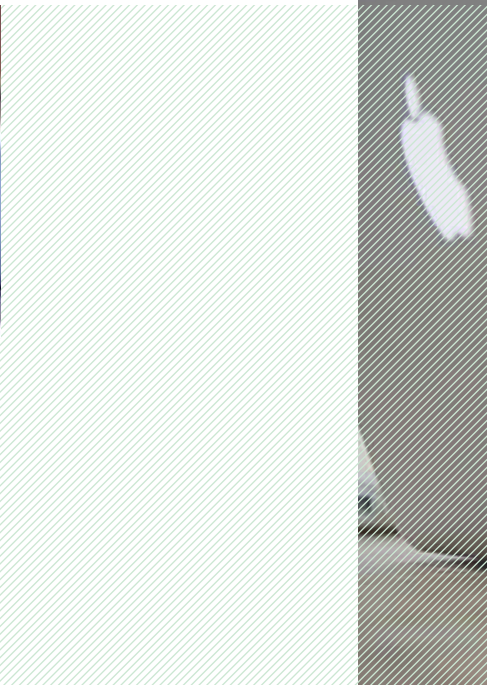
# TEACHING AND LEARNING

University of the Arts London offers distinctive education in art, design, fashion, communication and the performing arts in six distinguished Colleges across London. The passion and commitment of the staff and students to their subjects are among the University's significant strengths, as are the diverse student group and the high number of qualified teachers among the technical and academic staff.

Learning at the University is practice-based, creative and strongly linked with industry and the arts through live briefs, placements, exhibitions and performances. Much of the teaching and feedback for your studio-based project work takes place during discussions with your peers and tutors. Classroom activities and written work may also support your learning, depending on your course. The University uses virtual learning environments (VLEs), as well as other technologies such as blogs and online portfolios, to provide resources, information and opportunities for communication and collaboration.



# PREPARING TO STUDY

# FEES AND MONEY

There are a lot of things you need to think about before you start your course, and fees and money issues are some of the most important. Making arrangements for the payment of your course tuition fees is a significant and essential step towards becoming a student at the University.

You will need to think about more than just tuition fees – there is also the cost of accommodation, living and travel, as well as fees for equipment and materials, detailed in your course administration documents.

## Home and European Union students

The information in this section sets out course fees and available funding for students who are classified as Home (based on residence in the UK) or as European Union (EU). It is set out according to the type and level of course that you are doing – whether Further Education, Undergraduate or Postgraduate – with general information for all students starting on page 21.

## International students

The Fees and Money information for students from outside the European Union is different from what appears here. If you are an international student, the overseas fee rates will apply.

## Money for Further Education (FE) students

**Foundation Studies in Art and Design, ABC Diploma, Access to HE Diploma**

The information here is for Home and EU students.

Please read the following guidance with reference to the level of the course.

### Level of study

Listed below are Full Level 3 courses:

- **Foundation Diploma in Art and Design**
- **Access to HE Diploma**

Any other Further Education courses at the University are not Full Level 3 courses.

### Fees

You will normally pay your own fees. To qualify for fees at the Home/EU rate, you must satisfy requirements on both immigration status and on the length and purpose of residence in the European Economic Area (including Switzerland).

Students from outside the European Union will normally pay fees at the overseas rate.

### Under 19s

As a Home/EU student under age 19 on 31 August of the year that your course begins, you do not pay tuition or registration/examination fees, though you may have to pay additional fees to the University, e.g. for equipment or materials.

Access to HE Diploma and Foundation Studies in Performance students pay the full tuition fee.

### Under 25s

If you are a Home/EU student under age 25 on 31 August of the year your course begins, and you are on a Full Level 3 course and you do not already have a Full Level 3 qualification (equivalent to two A Levels, a BTEC National Diploma or an Access course), you will not pay tuition fees. However, you may have to pay for any additional fees, e.g. for equipment or examination fees. Foundation Studies in Performance students pay the full tuition fee.

### Concessionary fees

There is a concessionary (reduced) fee of £10 for Home/EU students aged 19 or over on 31 August who receive, or whose partner receives, certain means-tested UK social security benefits or tax credits. This does not include any additional course-related fees, e.g. equipment or materials.

### Fee remission

All other Home/EU students aged 19 or over on a full-time course can apply for fee remission (partly reduced fee). If granted, the maximum fee remission is 70 per cent of the tuition fee (50 per cent for some courses), but not the registration fee. Application forms will be sent in July 2012 and are available at your School or College Office or from a Student Adviser after enrolment. You must apply for help with fees within one month of enrolment.

### 16–19 bursary fund

Students aged between 16 and 19 years may be eligible for a bursary of £1,200 a year if you are: a young person in care; a care leaver; a young person claiming income support in their own name, or; a young person who receives both Employment Support Allowance and Disability Living Allowance in your own name.

### Residential Bursaries

If you have to live away from home to attend your course, you can apply for funding to help with the cost of accommodation. Application forms will be sent in July and you will need to return your completed form to the University before 31 August 2012 in order to be considered.

Please note that the University administers the grant for its own students as a 'Specialist Centre', unlike most other institutions.

### University of the Arts London Bursaries

The University has a number of bursaries for FE students, depending on family income.

## Money for Undergraduate students

### BA, BSc and Foundation Degree

If you started a course in 2011/12 but are considering transferring to another course and/or university, you may be able to continue with the current support package, rather than be charged the increased fee.

If you had a place for 2011/12, but deferred starting the course until this year, government policy states that you will be asked to pay the increased fees as a new student.

### Applying for student funding

If you meet the UK residency requirements as a Home student, you can apply to Student Finance England for your student support. You should apply as early as possible to avoid delays to your enrolment, preferably before 31 May 2012, as applications submitted after that date may be subject to delays which may mean that you will not be able to apply for all the funding you may be entitled to.

Students from the Channel Islands and the Isle of Man are subject to different funding arrangements to mainland UK students. For information on support available to you for tuition fees and living costs you should contact your relevant island education office.

### European Union

European Union nationals who do not meet the UK residency requirements but who are normally resident in the European Economic Area can apply as an EU student for a loan to pay the tuition fees only. You may also be able to apply for a partial fee waiver from the University as part of the National Scholarship programme. You cannot apply for a loan or grants to help with living expenses. ### EU/EEA migrant workers in the UK

If you are an EU or EEA national and are living and working in the UK prior to the start of your course, then you may qualify to be treated as a Home student and be eligible for the full package of student funding described below.

### Maintenance Loans and Grants for living costs

Home students can also apply for a Maintenance Loan for living costs. The amount you can borrow is on a scale between £2,843 and £7,675 (depending on where you live and study). You may be eligible for the higher rate of loan as well as a Maintenance Grant of up to £3,250, depending on your family income, or, if you are eligible to receive certain benefits, you may receive a Special Support Grant.

### Additional help

There is also extra help for students with dependent children, childcare costs, adult dependents and those with study costs associated with disability. For more details contact a Student Adviser.

### National Scholarship Programme (NSP)

Scholarships will be available to Home/EU students starting new courses in 2012/13. National Scholarship Programme awards will be worth £3,000 in the first year of study and £1,000 per year thereafter.

Eligible students will be those resident in England, but not those ordinarily resident in Scotland, Wales and Northern Ireland. Students from the European Union will only be eligible for the fee waiver element of the NSP.

You will be eligible to be considered for an NSP award if your declared household income is under £25,000, although the University's scheme will give priority to those with a declared household income of under £16,000.

Students who qualify for an NSP award can choose from:

- A fee waiver;
- Support in kind from the University; or
- A maintenance bursary of £1,000 (this element is not available to part-time or EU students) up to a total value of £3,000.

### Part-time students

Home/EU part-time students starting a new course in 2012/13 will be eligible to apply for a Tuition Fee Loan to cover the cost of your fees in the same way that full-time students do. You will be able to borrow the full tuition fee up to a maximum of £6,750 which is paid directly to the University.

The main body that provides postgraduate funding for UK-based students in the University's core subject areas is the Arts and Humanities Research Council (AHRC). Applications for courses that start in 2012/13 must have reached your School or College Office by 1 March 2012. All applications must be made through your College. ## General money information for all students

### Scholarships and bursaries

The University offers a wide range of financial assistance to its students. Scholarships and bursaries are often dependant on the level or type of course and family income.

### Access to Learning Fund (ALF) / Learner Support Funds (LSF)

These are government funds to provide small grants to help with study costs if you find yourself in financial difficulty once you have enrolled. To apply, you must fulfill requirements relating to your residence.

Part-time students may also apply, but must normally be undertaking studies equivalent to at least 50 per cent of a full-time course.

### External charities and trusts

Some students can receive limited help from independent organisations, such as charities, trusts and foundations. To apply, you must match the requirements of the organisation. Only apply if you meet their criteria. The Educational Grants Service (EGS) specialises in assisting students to find appropriate charities. ### Council Tax

All students under 18 do not pay Council Tax and are not included in any calculations for the bill. Certain other students are exempt from paying Council Tax. If you are studying on a qualifying full-time course, you can get a Council Tax Exemption Certificate from your School or College Office to send to your local council. The property is then exempt if you live alone or with other full-time students. No one in the property should receive a bill for Council Tax.

If you live with other people who are not full-time students and who have to pay Council Tax, then the flat/house will receive a bill. Your name should not be included on it and you will not be legally expected to pay. However, you may need to negotiate this with your flatmates.

If you are not entitled to a Council Tax Exemption Certificate, and you can meet the benefits rules, you should apply to your local council for Council Tax Benefit. If you are sent a Council Tax bill do not ignore it. You can be taken to court if you do not pay and can be charged extra costs.

Contact your Council if you think your bill is wrong or contact a Student Adviser for advice.

### State benefits

Full-time students cannot normally claim state benefits such as Income Support, Jobseeker's Allowance, Housing Benefit, Employment and Support Allowance, and Council Tax Benefit. However, there are exceptions for students with a disability, single parents and student couples with a child (in the summer vacation only). Part-time students are normally able to claim benefits, but will need to meet the relevant benefit rules.

Note that, for undergraduate students, the Maintenance Loan is counted as income and will affect how much benefit you receive. Whether you take all or part of the loan, the benefit office will stop or reduce any benefit according to the maximum amount you are entitled to borrow. Starting a course is a change of circumstances that you should inform your benefit office of once you have enrolled.

### Tax credits

There are a number of tax credits for which you may be eligible, dependant on your own particular circumstances: Child Tax Credit is for all families with children, while Working Tax Credit is a payment to top-up earnings and help with childcare for working people on low incomes. Pension Credit is for people aged 60 – 65 or over, whichever is your minimum qualifying age. You can get a claim form from the Pensions Service on +44 (0)800 991234, textphone +44 (0)800 1690133, or visit [www.direct.gov.uk/pensioncredit](http://www.direct.gov.uk/pensioncredit)

### Student accommodation

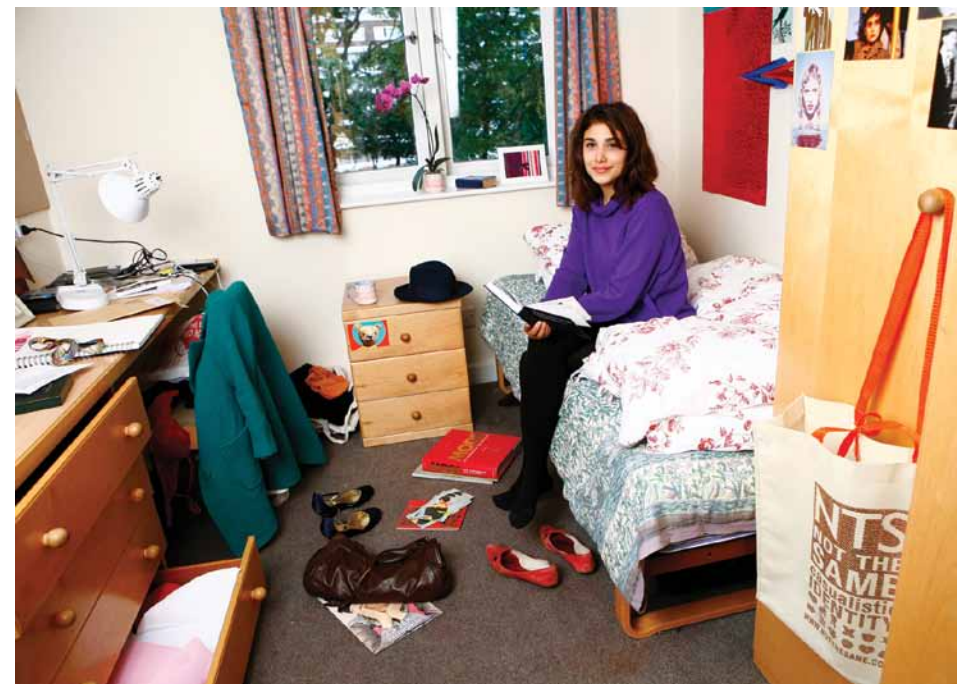

The University opens two new halls of residence in September 2012. Camberwell Campus offers accommodation in newly refurbished Georgian town houses opposite Camberwell College of Arts. 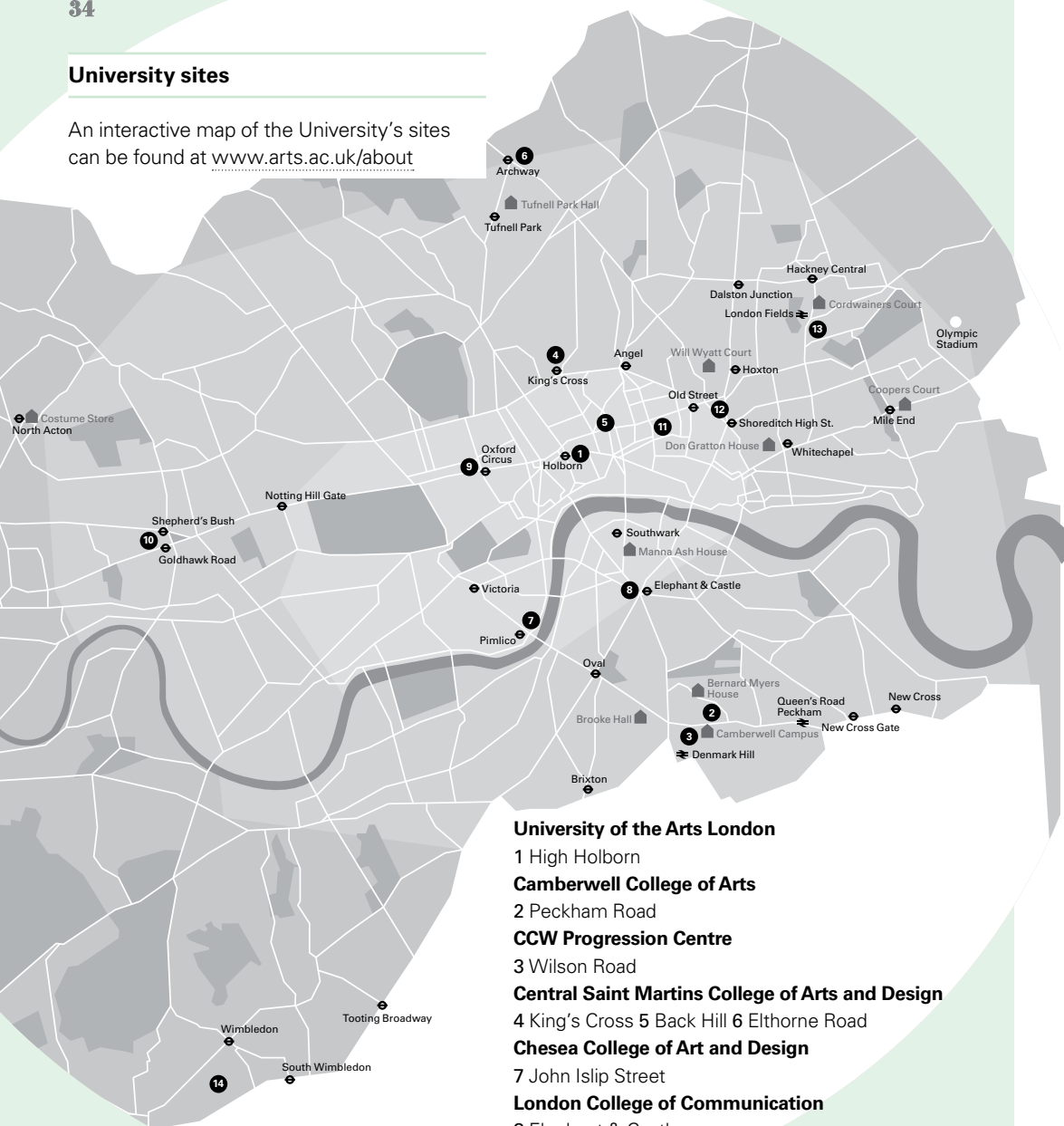
