Students also study elements of one other area of legal studies, the '8th subject', notably Employment Law or Social Welfare Law and Practice; and they can choose one other subject area of their choice. This part of the programme is completed largely by self-managed study and is assessed by a coursework assignment submitted at the end of the year (after the exams have been completed).

how to apply and entry requirements

GDL/CPE – Entry requirements

Entrants should preferably hold at least a second class honours degree but, a third class degree will be considered where the applicant has aptitude and relevant work experience.

Applicants should be guided by the Law professional bodies, as other entry gualifications may be applicable, for example the ILEX held by legal executives or if entrants have "mature student" status.

Applicants are responsible for ensuring that they have the requisite entry gualifications for the course including a Certificate of Academic Standing from the SRA or BSB, if this is required (see below) and for their intended progression route. They should obtain confirmation of subject exemptions that might be available.


GDL/CPE – How to apply
