Bond University has a distinctly global perspective, aspiring to a 50 : 50 ratio of Australian to international students. Our international students come from over 80 countries, evenly weighted so that no nationality dominates, to ensure a balanced classroom. The Bond global alumni network is active in over 120 countries around the world, so you'll be connected practically anywhere your ambition may take you.

## **STUDYING AT BOND**

Bond University offers three semesters a year, allowing you to complete your studies much earlier than at other universities. For instance, a standard master's degree that takes two years with the normal two-semesters-per-year timetable, can be completed in one year and four months at Bond.

This accelerated study mode, combined with the flexibility of our cross-faculty subject offerings, gives you the opportunity to tailor your degree studies to suit your specific career goals or enhance your employability by gaining extra qualifications.

#### **POSTGRADUATE STUDY**

Bond University offers a range of higher degrees by coursework or research.

Admission to postgraduate coursework degrees generally requires an undergraduate qualification from a recognised institution. In some cases, however, extensive career experience in a relevant discipline may meet the entry criteria.

Doctoral studies are completed predominantly through research, guided and supervised by specialist advisors. Each faculty and the Institute at Bond incorporates world-renowned research centres, headed by international authorities in their respective fields.

#### BACHELOR'S DEGREE (GRADUATE ENTRY)

Students can enter some bachelor programs via graduate entry, such as our Bachelor of Medicine Bachelor of Surgery.

#### HONOURS DEGREE

An honours degree is usually two or three semesters of additional coursework, seminars and supervised research taken after a bachelor's degree. It advances your knowledge and experience and helps prepare you for future research work and higher degree programs. A high level of achievement in an undergraduate course is a prerequisite of entry into an honours degree program. Honours degrees are available in the faculties of Business, Health Sciences & Medicine, Humanities & Social Sciences (Psychology only) and Law.

#### **GRADUATE CERTIFICATE**

These one-semester professional development programs generally comprise four subjects and serve as an ideal introduction to postgraduate study. This is particularly ideal for working professionals who cannot commit the time for a full master's degree. Subjects completed can be credited towards a postgraduate diploma.

#### POSTGRADUATE DIPLOMA (GRADUATE DIPLOMA)

Completed in just eight months (two semesters), the Postgraduate Diploma normally comprises eight subjects. This is an excellent option for those wishing to update their skills and qualifications in a specialist area and can be credited towards a full master's degree\*.

#### MASTER'S DEGREE

Master's degrees are available in a wide range of disciplines in all faculties and the Institute of Sustainable Development & Architecture. They generally comprise 12 subjects which can be undertaken by coursework only, a combination of coursework and research, or by research only.

#### **DOCTOR OF PHILOSOPHY (PhD)**

Higher Degrees by Research are completed predominantly through research, with candidates guided and supervised by specialist advisors. The PhD degree may be awarded for thesis only, or thesis and coursework, or publication.

#### DOCTORATE

Doctoral degrees are offered by Bond in the areas of legal science, laws, health sciences and physiotherapy.

\*Excludes Psychology. Please refer to pages 85 and 87 for Psychology specific outcomes.



#### **PROFESSIONAL DEGREES**

Professional degrees (92 weeks duration) are open to all students eligible to undertake master's level postgraduate studies. These degrees are offered within the following areas.

#### Faculty of Business

Professional degrees are offered through the Faculty of Business in the areas of accounting, business, business systems, service management, information technology and hotel, resort and tourism management. All professional degrees are available each semester and have a duration of four semesters plus 20 weeks (92 weeks).

These degrees follow the same course structure as that of the existing degrees, but include a 20 week Work Integrated Learning component designed to promote and support student learning, personal development and professional practice.

#### Faculty of Humanities & Social Sciences

Professional degrees in Humanities & Social Sciences are offered in the areas of communications, international relations and criminology. All professional degrees are available each semester and have a duration of four semesters plus 20 weeks (92 weeks).

These degrees follow the same course structure as that of the existing degrees, but include a 20 week professional segment – an additional study and experience component undertaken toward the completion of the degree.

#### Institute of Sustainable Development & Architecture

Professional degrees are offered in the areas of sustainable development and property valuation. These are available each semester and have a duration of four semesters plus 20 weeks (92 weeks).

#### **CREDIT TRANSFER**

Subject credits may be available for previous tertiary studies in a relevant or related field. You can apply for subject credits on the Bond University application form by including certified copies of transcripts from your previous studies, detailed course outlines and subject descriptions.

#### STUDY SCHEDULE

Bond's teaching methodology involves a combination of lectures, tutorials, seminars, examinations, projects, presentations, assignments, computer labs and industry projects.

## PATHWAYS INTO BOND UNIVERSITY

If you do not meet the stated academic requirements for direct entry into a postgraduate degree program, Bond College offers an alternative pathway.

#### MASTER'S QUALIFYING PROGRAM

Duration:	14 weeks (1 semester)
Starting:	January, May, September

The Master's Qualifying Program is a 14 week (one semester) course of study developed in close collaboration with the University faculties, and designed to prepare international students for a selected range of Bond University postgraduate degree studies.

Currently open to Australian and international students, the Master's Qualifying Program offers access to the following postgraduate programs, provided faculty and degree specific entry requirements are satisfied.

- Master of Accounting
- Master of Business
- Master of Business Administration
- Master of Finance
- · Master of International Hotel and Resort Management

#### FACULTY OF HUMANITIES & SOCIAL SCIENCES

- Master of Criminology

- Master of International Relations

Entry into other faculties will be assessed on an individual basis. The programs commence in each semester – January, May and September.



### ENTRY REQUIREMENTS

The Bachelor of Medicine Bachelor of Surgery (MBBS) program is an undergraduate program, however it is also open to those who have completed a degree. Enrolments in the program are strictly limited to ensure small class sizes and sufficient clinical placements. As such, entry is extremely competitive.

Postgraduate applicants will be evaluated based on the following equally weighted criteria:

- GPA from previous university degree (completed no more than nine years earlier) which also demonstrates qualifications at least equivalent to Queensland Year 12 Chemistry, Maths B and English. Applicants who do not meet these requirements must complete an approved bridging course before their application can be considered.
- A structured interview ranking. Applicants are selected through a rigorous assessment process based on outstanding academic achievement, in combination with demonstrated ability to achieve graduate outcomes of knowledge and critical thinking, leadership, initiative and teamwork, communication skills and responsibility, ethical decision-making skills, motivation, critical thinking and non-verbal reasoning.

Short-listed applicants will be required to attend an interview in person at Bond University where their general suitability to medicine and preparedness to undertake a highly demanding course will be examined in a structured multi-mini interview (MMI), comprising eight individual interviewers from both medical and non-medical backgrounds who are trained in entry-style medicine interviews. Bond University is committed to easing the shortage of medical practitioners in Australia and therefore applications to the MBBS program are only open to Australian citizens, Australian permanent residents and holders of an Australian humanitarian visa. Applications are also open to New Zealand citizens but not to New Zealand permanent residents. Bond University may accept applications for applicants on behalf of foreign governments to which it has entered into specific arrangements.

#### **PROGRAM DESCRIPTION**

The Bachelor of Medicine Bachelor of Surgery (MBBS) offers direct entry to both Year 12 school leavers and university graduates. Established by one of the world's leading authorities in ensuring best medicine practice based on evidence (Evidence-Based Medicine), the program is distinguished by its strong educational focus on problem-based learning. Rather than studying one specialist subject area at a time, the curriculum challenges you with clinical cases that combine a range of symptoms, possible diagnoses and disciplines. Essentially, it puts you in real-life clinical situations from day one.

The holistic learning strategy is complemented by extensive clinical practice and patient contact integrated with the theoretical study elements. 

Applicants must also be eligible for provisional registration as a psychologist. Applicants are assessed on academic performance, referee reports and personal suitability via interview. You must obtain provisional registration from the Psychology Board

of Australia before commencing the program.

#### **PROGRAM DESCRIPTION**

This program is designed for individuals seeking registration as a clinical psychologist or for registered psychologists seeking to upgrade their existing qualifications. The program provides in-depth training in the diagnosis, assessment and treatment of psychological disorders across a wide range of client populations. There is an emphasis on the scientist-practitioner approach.

This program is also designed to provide education, knowledge, training and clinical skills in professional psychology, to meet the requirements for registration as a psychologist.

Placements are an integral part of this program. You will undertake practical placements as part of your clinical training.



Completion of an Australian Psychology Accreditation Council accredited four year sequence of study in Psychology (such as Bachelor of Social Science (Psychology) with Honours, Postgraduate Diploma of Psychology) or equivalent within the last 10 years, and have achieved a minimum upper second class honours (H2A) or equivalent.

Applicants must also be eligible for provisional registration as a psychologist. Applicants are assessed on academic performance, referee reports and personal suitability via interview. You must obtain provisional registration from the Psychology Board

#### **PROGRAM DESCRIPTION**

This program provides an in-depth analysis of the interface between psychology and law in relation to the criminal courts, as well as family and civil matters. The course covers all stages of the criminal justice system from investigation and interview through to pre-trial psychological assessment, involvement at the pre-sentencing stage and the treatment of convicted offenders. There is an emphasis on the scientist-practitioner approach.

This program is also designed to provide education, knowledge, training and clinical skills in professional psychology to meet the requirements for registration as a psychologist.

Placements are an integral part of this program. You will undertake practical placements as part of your training.

Minimum requirement for admission is:

- A qualification or combination of qualifications deemed to be equivalent to the above by the Higher Degrees by Research Committee.

Candidates who have completed more than nine months of a master's by research or the Master of Philosophy and who meet the requirements for admission to PhD candidature may apply to be admitted to confirmed PhD candidature. In successful cases, the PhD candidature will be considered to have begun at the time of commencement of the research master's degree.

#### ENTRY REQUIREMENTS

A prior degree in any discipline. Applicants would normally be required to have at least a 70 per cent grade average. Consideration is also given to relevant work experience and referees' reports on the suitability of the applicant for studying law.

#### **PROGRAM DESCRIPTION**

The Juris Doctor is a professional legal qualification which prepares you for a career in the legal profession, business, industry or government, in Australia and overseas.

Bond's Juris Doctor provides an engaging learning experience that both challenges students academically and prepares them practically for a legal career. The legal skills program (comprising 20 components) equips graduates with the following skills needed to practise law in today's world:

- · Client interviewing and communication
- · Legal research and analysis
- Legal writing and drafting
- · Negotiation and dispute Rrsolution

#### PROGRAM STRUCTURE

The Faculty also encourages you to complete clerkships or internships with law firms during your holidays but these do not form part of course requirements. Some students will plan to seek admission as a lawyer on the completion of their Juris Doctor, while others will be well established in their careers and will be undertaking the Juris Doctor in order to enhance their career options.

The Bond Law Juris Doctor is specifically designed to develop well rounded legal practitioners equipped with the practical legal skills to take leading positions in both the public and private sectors. An undergraduate degree in any discipline.

#### **PROGRAM DESCRIPTION**

Those looking to broaden their skill and knowledge gained in an undergraduate program (including law) or to specialise in a professional area should consider the Postgraduate Diploma in Law. This program is an ideal entry point for a Master of Laws degree. Some students may complete a generalist diploma while others choose an area of specialisation (electives outlined below).

#### **PROGRAM STRUCTURE**

You must complete the following subjects:

- · Advanced Legal Research and Writing
- Introduction to Common Law

Plus two master's level electives chosen in accordance with the relevant area of specialisation:

- Alternative Dispute Resolution
- Corporate and Commercial Law
- Intellectual Property, Information Technology and E-Commerce Law
- International Trade Law

#### PROFESSIONAL OUTCOMES

The Postgraduate Diploma in Law provides a specialist postgraduate qualification to augment a graduate's existing area of expertise. For those who have completed a Bachelor of Laws or Juris Doctor degree, this program also meets the entry requirements for a Master of Laws, Master of Business Law and Master of Jurisprudence, with subjects qualifying for credit.

#### **PROFESSIONAL RECOGNITION**

The Postgraduate Diploma in Law is not a professional degree and does not qualify graduates to practise law in Australia.

#### PROGRAM DESCRIPTION

The Postgraduate Diploma of Legal Practice (PLT) is the link between your degree and becoming a practising lawyer. The PLT program is an alternative to undertaking a legal traineeship for admission in Queensland. Our PLT Program is a coursework degree that provides structured and supervised legal training, based on the Competency Standards for entry level lawyers developed by the admitting authorities and the Australian Professional Legal Education Council.

In addition to applying for admission, upon completion of the PLT program, you have the option of continuing your studies to obtain a Master of Laws (Legal Practice), specialising in Alternative Dispute Resolution (refer to course details on page 99).

#### **PROGRAM STRUCTURE**

You will complete a practical training component in addition to a 75 day placement in a law office. The work experience can be undertaken in more than one office, and the Faculty's Graduate Development Office can assist you in seeking your placement. This practical experience will be augmented by 75 hours of continuing practical training completed concurrently. This is undertaken by distance education mode during the placement period. The program concentrates on the development of 'lawyering' skills such as legal research, analysis and problem solving, legal writing and drafting, interviewing and oral communication, advising, advocacy, dispute resolution, professional ethics and conduct and accounting. These skills are taught in a practical context in a simulated office environment.

#### **PROFESSIONAL OUTCOMES**

Successful completion of the Postgraduate Diploma of Legal Practice enables graduates to apply for admission to legal practice. You should contact the relevant admitting authority to ascertain the requirements for admission in your state or territory. Mutual recognition legislation also facilitates the process of practitioners admitted in one state seeking admission in other Australian jurisdictions.



# MASTER OF BUSINESS LAW

Duration:8 months full-time (2 semesters)Starting:January, May, September

# MASTER OF JURISPRUDENCE

Duration:8 months full-time (2 semesters)Starting:January, May, September

#### ENTRY REQUIREMENTS

The Master of Business Law and Master of Jurisprudence may be undertaken by those who have a non-law undergraduate degree. Applicants would normally be required to possess at least a 70 per cent grade average and / or extensive professional experience.

#### **PROGRAM DESCRIPTION**

The Master of Business Law and Master of Jurisprudence provide opportunities for those from non-law or quasi-legal backgrounds to gain a postgraduate law qualification that focuses on areas of law that are directly relevant to their professional ambitions, such as corporate and commercial law, international trade law, IP law and dispute resolution.

#### PROGRAM STRUCTURE

You must complete the following introductory subjects:

- Advanced Legal Research and Writing
- Introduction to Common Law

Plus six master's level law electives.

If appropriate supervision is available, you may elect to replace two elective subjects with a minor dissertation upon approval by the Dean or delegate.

You may complete a generalist degree or qualify for one of the following specialisations by completing at least four of your electives in an area of study:

- Alternative Dispute Resolution
- Corporate and Commercial Law
- Intellectual Property, Information Technology and E-Commerce Law
- International Trade Law

#### **PROFESSIONAL OUTCOMES**

The Master of Business Law and Master of Jurisprudence provide a specialist postgraduate qualification in fields such as corporate and commercial law, international trade law, IP law and dispute resolution. While these degrees do not qualify our graduates to practise law, they do provide an excellent introduction to the concepts and applications of law in today's global society.

#### PROFESSIONAL RECOGNITION

These awards are not professional degrees and do not qualify you to practise law in Australia. Those wishing to practise law should consider a Bachelor of Laws or Juris Doctor.



# **MASTER OF LAWS**

Duration:8 months full-time (2 semesters)Starting:January, May, September

#### ENTRY REQUIREMENTS

The Master of Laws program is offered to those with a professional law qualification (Bachelor of Laws, Juris Doctor or equivalent). Applicants would normally be required to have at least a 70 per cent grade average and / or extensive professional experience.

#### **PROGRAM DESCRIPTION**

The Master of Laws is a postgraduate law qualification that provides maximum flexibility and choice with a wide range of specialist areas, meaning you can design your master's degree to suit your area of interest and professional needs. Those looking to expand their knowledge in a particular area will benefit from the investigations into contemporary legal issues from both international and local perspectives while developing legal research and writing skills.

You may complete a generalist degree or qualify for one of the following specialisations by completing at least four electives in that area of study:

- · Alternative Dispute Resolution
- Corporate and Commercial Law
- Intellectual Property, Information Technology
   and E-Commerce Law
- International Trade Law

#### PROGRAM STRUCTURE

You must complete the following introductory subjects:

- Advanced Legal Research and Writing
- Introduction to Common Law

Plus six electives chosen from the postgraduate list of law electives in accordance with the relevant area of specialisation. If appropriate supervision is available, you may elect to replace two elective subjects with a minor dissertation upon approval by the Dean or delegate.

#### **PROFESSIONAL OUTCOMES**

The Master of Laws provides a postgraduate qualification that broadens a graduate's or practitioner's knowledge in a chosen area of specialisation.



# MASTER OF LAWS (INTERNATIONAL LEGAL PRACTICE)

Duration:16 months full-time (4 semesters)\*Starting:July

#### ENTRY REQUIREMENTS

A professional legal qualification (Bachelor of Laws, Juris Doctor or equivalent) and commitment to undertake the practicum in a country other than country of residence.

#### **PROGRAM DESCRIPTION**

The Master of Laws (International Legal Practice) is an innovative internationally-focused degree which combines a coursework master's degree with a practical legal placement in a professional legal setting.

#### **PROGRAM STRUCTURE**

You must complete the following introductory subjects:

- Introduction to Common Law
- Advanced Legal Research and Writing

Plus four (or five) master's level law electives along with an internship (two or three subjects equivalent). If you undertake four elective subjects your full-time internship will take a duration of six months. However, if five elective subjects are chosen, the internship is reduced to three months.

#### PROFESSIONAL OUTCOMES

The Master of Laws (International Legal Practice) provides you with an international perspective on your master's studies, as well as the experience of working in a law firm in another country. Graduates are now working as attorneys and barristers for the finest law firms across 18 countries, including Wragg and Co in London and Reed Smith in New York.

\*Students must complete a full-time placement for three or six months (two or three subjects equivalent). The placement may be in Australia or overseas, and must be in a country other than the student's country of residence. In an era of global practice this provides an opportunity for students to experience legal practice outside their home jurisdiction.

#### ENTRY REQUIREMENTS

Completion of a Bachelor of Laws or Juris Doctor program (or equivalent) at an approved institution, subject to the decision of the Dean or delegate. Successful completion of Bond University's PLT. Applicants would normally be required to have at least a 70 per cent grade average and / or extensive professional experience.

#### **PROGRAM DESCRIPTION**

The Master of Laws (Legal Practice) is an innovative professional degree that combines practical legal training with specialist postgraduate subjects in areas related to legal practice. The specialist areas for this master's are Dispute Resolution and Advocacy.

#### **PROGRAM STRUCTURE**

The Master of Laws (Legal Practice) is a 100 credit point program incorporating the Postgraduate Diploma in Legal Practice (PLT). You will receive 35 credit points for successful completion of PLT. The remaining 65 credit points are made up of three components.

You must complete the following five subjects:

- Advanced Legal Research and Writing.
- One individual directed research project (equivalent to one postgraduate subject) within an area covered by PLT.
- Three postgraduate law electives, including two from the areas of Advocacy or Alternative Dispute Resolution.

#### **PROFESSIONAL OUTCOMES**

The PLT program that forms part of the Master of Laws (Legal Practice) entitles law graduates to apply for admission as a legal practitioner in Queensland.





# DOCTOR OF LEGAL SCIENCE (RESEARCH)

Duration: 8 - 18 semesters full-timeStarting: Anytime throughout the academic year

#### ENTRY REQUIREMENTS

Applicants must have a Bachelor of Laws or Juris Doctor with Honours or a Master of Laws degree.

Candidates for the Doctor of Legal Science (Research) degree must satisfy the Dean that they have the academic, research and writing abilities to produce a major dissertation in English of not more than 50,000 words which represents a substantial contribution to the exposition, knowledge or understanding of the field of study concerned.

Admission is on the basis of an approved research proposal and availability of appropriate supervision. Applicants are required to complete six electives chosen from the list of postgraduate subjects before undertaking the thesis component.

Alternatively, admission may be awarded through transferring from the Master of Laws coursework to the thesis component of the research. Applicants will have achieved an average of at least 75 per cent in the Master of Laws coursework. The research proposal must be approved by the Faculty and appropriate supervision must be available.

# PROGRAM STRUCTURE

You must complete:

- Six electives chosen from the subjects listed under Master of Laws.
- A major dissertation of approximately 50,000 words, which represents a substantial contribution to the exposition, knowledge and understanding of the field of study and which demonstrates a capacity for independent research. The topic must be approved by the Faculty and appropriate supervision must be available.

#### PROFESSIONAL RECOGNITION

This program is a doctoral-level degree.

#### DOCTOR OF PHILOSOPHY

Duration: Minimum 3 years and a maximum 4 years full-time

Starting: Anytime throughout the academic year

#### ENTRY REQUIREMENTS


Applicants must have:

- Completed a master's degree from a recognised university; or
- Completed a Bachelor of Laws degree from Bond or another recognised university with an average of at least 75 per cent or an equivalent grade elsewhere; or
- Other qualifications which, in the opinion of the Academic Senate, acting on the advice of the Dean, are equivalent to or are a satisfactory substitute for either of the qualifications prescribed above.

In addition to the above requirements, candidates for the PhD degree must satisfy the Dean that they have the academic, research and writing abilities to produce a major thesis that represents a substantial contribution to the exposition, knowledge or understanding of the field of study concerned.

#### **PROGRAM STRUCTURE**

The Doctor of Philosophy program is a research higher degree awarded for a substantial thesis or for published papers, which is a significant contribution to the knowledge or understanding of an aspect of law. The PhD will display the capacity of the student to carry out independent research at the appropriate level. PhD candidates are required to submit for external examination a written research thesis of between 70,000 to 100,000 words. The topic must be approved by the Faculty of Law and appropriate supervision must be available.

The program covers a number of key areas associated with strategic property management, refurbishment, operational management, financial planning and dispute resolution related to facilities portfolios, and also enables participation in the crossdisciplinary related project.

The dissertation should be a major, substantially original, theoretical or empirical study of an issue pertaining to your major field of study. The Institute expects you to work closely with staff and be exposed to the research activities of the staff and other students. It would not be uncommon to co-author with your supervisor in publications resulting from your dissertation.

## **PROFESSIONAL OUTCOMES**

The Doctor of Philosophy provides you with the research skills for academic careers in the university sector or for the role of researcher in business research-intensive organisations.

## SUPPORT SERVICES

Bond values the cultural differences and diversity brought to the campus by its international students and makes every attempt to ensure they feel welcome. Individual academic counselling is also available to all students from a non-English speaking background. International students also have access to an International Student Support Officer, located in student administration, who can provide visa advice and support while you settle in.

## **COMPUTER SUPPORT**

Information Services operates a Service Desk to help students needing computer support. The Service Desk supports all University-owned equipment, as well as providing instruction for connection of privately owned equipment to the network.

#### COMMERCIAL CENTRE

Your everyday needs are well catered for and easy to access at the on-campus Commercial Centre where you will find ATMs, the University bookshop stocking all required texts, a printing shop and a travel agent.

#### COUNSELLING SERVICES

Qualified student counsellors offer a totally confidential on campus counselling service to assist with anything from transitioning or returning to university, to study pressures and personal problems. During the course of each semester Counselling Services also run Life One, a weekly life skills program aimed at developing positive coping skills and self-awareness complementing academic endeavours to produce more competent, resilient and grounded graduates.

## **DISABILITY SUPPORT**

If you have a disability, illness, injury, mental or health condition that you believe may affect your capacity to complete your studies, exams or assessment tasks, it is important you contact a Disability Officer to discuss strategies and / or academic adjustments that may be required. If you would like to be considered for support, you will need to complete an application form and submit it with recent and comprehensive specialist documentation to the Disability Office before Week 4.

#### MEDICAL SERVICES

The on-campus Student and Staff Medical Clinic provides general medical treatment, advice and testing, referrals, immunisation and vaccinations. The campus doctor and nurse are available for appointments from Monday to Friday.

## PASTORAL CARE

Bond University is a non-denominational campus. However, our Pastoral Care services can provide information about local worship centres and different faiths.

## SECURITY

The Bond University campus is patrolled 24 hours a day, seven days a week, by our on-staff security officers and monitored by security cameras. Security officers can be contacted at any hour by phone to assist in an emergency or even just to walk you to your car after dark.

#### STUDENT LEARNING SUPPORT

# INVESTING IN YOUR FUTURE

Your university degree is one of the most important investments you will make in your lifetime. As with all investments, you must consider the rate of return of both the short term career opportunities and your long term lifetime earnings.

## FINANCING YOUR DEGREE

Bond University is a not-for-profit, private independent university which means that fees are directly reinvested to provide an outstanding education and facilities for students.

Tuition is charged at the beginning of each semester as you enrol. The fees payable by international students are the same as those for Australian students.

Students will need to meet the cost of living expenses, textbooks and other equipment. At Bond University you will not need to budget for on-campus parking as it is made available free of charge to all students. The use of the sporting facilities is covered by the Student Activities Membership.

You are encouraged to speak to financial institutions about any services they can provide to help finance study. There are a number of options available to help you finance your educational investment with assistance available from Bond University, government loan programs, personal bank loans and scholarships.

## FEE-HELP

If you are an Australian citizen or a holder of a permanent humanitarian visa and have a Tax File Number, you will be able to access the Australian Government's loan scheme called FEE-HELP. FEE-HELP is an interest free loan that helps eligible fee paying students pay their tuition fees. The accumulated debt is indexed annually according to the Consumer Price Index (CPI).

Eligible students who wish to pay for part or all of their tuition fees through FEE-HELP must complete a Request for FEE-HELP Assistance form by the end of the second week of the semester. You can then elect to pay a portion of fees directly to the University, and the remaining debt will be deferred as a loan through the Australian Taxation Office. If you are using FEE-HELP to cover all tuition costs and you don't complete the form by the end of Week 4, you will be liable for payment of all tuition fees.

Eligible students may borrow up to the FEE-HELP limit to pay their tuition fees over their lifetime. The FEE-HELP limit is the total amount available to an eligible student under both the FEE-HELP scheme and the VET FEE-HELP scheme and includes study at a TAFE institution and fee paying undergraduate degree. In 2012 the maximum loan amount available is AUD\$89,706. The FEE-HELP limit is indexed each year. The loan is repaid to the Australian Taxation Office taking compulsory repayments through the taxation system when your repayment income exceeds AUD\$47,196 in a financial year. A five per cent bonus is granted for any voluntary repayments over AUD\$500 made directly to the Australian Taxation Office. Please visit www.studyassist.gov.au for current loan thresholds and to view the Government publications on FEE-HELP. Maximum limits are adjusted each year.

## YOUTH ALLOWANCE / AUSTUDY

If you are an Australian citizen or permanent resident aged 16 years or over and studying full-time, you are eligible to apply for Austudy / Youth Allowance benefits from the Commonwealth Government. For more information, contact Centrelink directly.

## STUDENT OPPORTUNITY FUND

You will have the opportunity to undertake a range of experiences and activities which will enhance your university and learning experience while studying at Bond. To assist you in accessing these opportunities the Student Opportunity Fund was created for students to apply for financial assistance up to AUD\$2,000.

## LIVING COSTS

You should allow approximately AUD\$6,000 for living costs each semester that you live on the Gold Coast. This may vary depending on your budget for rent, food, transport, clothing, recreation, text books, telephone, electricity and other living expenses. At Bond University you will not need to budget for on-campus parking as it is made available free of charge to all students.

- To apply:
- Lodge an application through QTAC www.qtac.edu.au. You will be required to provide all accompanying documentation, providing evidence of your subject results in Chemistry, English and Maths B (or equivalent).
- Applications will then be assessed by the Faculty of Health Sciences & Medicine to determine your eligibility based on an assessment of academic performance.
- Short-listed applicants will be asked to attend an on-campus interview.

#### ENROLMENT PROCEDURES

Successful applicants will receive a formal Letter of Offer from Bond University, accompanied by a Response to Offer form and information on fee payments and accommodation.

To accept your place, return the Response to Offer form and your initial fee payment equivalent to the fee for one subject, or a completed Request for FEE-HELP assistance form\* to the Office of Admissions at Bond University. An Enrolment Guide and information about Orientation Week will be available on the Bond website approximately one month prior to semester commencement. Once you have accepted your offer, you can enrol in your subjects online via eStudent at any time prior to or during Orientation Week. The balance of your semester's fees need to be paid to Bond University prior to Orientation Week.

## DEFERMENT

Once you have been offered a place, you may apply to postpone your first year of study by completing Bond University's Response to Offer form, selecting the deferment option and returning it to the Office of Admissions.

Deferment is not available to students offered a place in the Bachelor of Medicine Bachelor of Surgery, Master of Psychology (Clinical) and Master of Psychology (Forensic). Deferments of scholarships will only be granted in exceptional circumstances.
